### Community Connect and ACOA – Debbie Card

- Question about what may happen in December when 5-year grant is supposed to end.
- The program was extended for another year.
- Additional SW for IHSS and four CMCT SW to form new unit in Antioch.
- This program receives funding from State, in conjunction with CCC Health Services.
- It has proved to be a money saving program.
